Please take the time to fill out all three patient information forms and submit on line, OR print them and bring the completed forms with you to your scheduled appointment. We have requested general information such as your name, address, phone number and specific information about your personal insurance coverage. Please bring your insurance card(s) with you. There are also a number of questions about your medical history and your family's medical history that might pertain to your care. It is of GREAT IMPORTANCE TO BRING YOUR PRESCRIPTION DRUG, VITAMINS AND SUPPLEMENTS' CONTAINERS with you so that your surgeon is aware of all of your medications.

With the exception of Medicare and Medicaid patients, our policy is to expect payment for the office visit at the time of service, if we are not a participating provider with your insurance company. Your insurance company requires that we collect the office visit co-pay at the time of service. Should you be scheduled for surgery, our staff will provide you with information about our charges at that time.

Prior to your first visit, you may wish to contact your employee benefits department. It is your responsibility to know if your plan requires that you go to a specific hospital or use a specific laboratory or x-ray facility. Please let our staff know if this is the case.

It is our policy to take care of all patients. If you are uninsured, we are more than willing to work with you. Please make contact with our insurance department at 424-9972 to discuss options. Please do not hesitate at any time to call our office should you have questions.
